I understand ALL cattle present at this sale shall meet the following requirements:

Tuberculosis: Dairy Cattle: Negative test within 60 days for all sexually intact animals greater than 6 months of age.

Beef Cattle:

- **Modified Accredited Advanced Counties in Michigan (Alcona, Alpena, Montmorency, Oscoda) -**
Negative Test within 60 days (all ages and includes steers/spayed heifers/sexually intact)
- **Free States -** No Test required

Trichomoniasis: Bulls imported into Oklahoma must have a negative test within 60 days prior to entry. Bulls within the state must have a negative test within 60 days prior to the sale. Exceptions are virgin bulls less than 18 months of age for out of state bulls and 24 months for in-state bulls.

Brucellosis: Cattle from Brucellosis Free states do not require a test to enter Oklahoma

All cattle consigned from out of state must have a Certificate of Veterinary Inspection signed by an accredited veterinarian with USDA approved official identification, breed, age, and sex of animal as well as testing information and permit number if required.

Sale management agrees to verify that:

- Cattle from out of state have a properly completed CVI
- Have complete records of both seller's and buyer's full name, address, and phone number
- Official identification for all cattle sold

Sale management agrees to send the above information to Animal Industry Services within 15 days of the sale or maintain all records in an easily retrievable location for a minimum of five (5) years. Records maintained by sale managers must be made available to ODAFF when requested. For sale managers wishing to submit information, a spreadsheet is available on the ODAFF website (ag.ok.gov) as a guideline for the required information and can be submitted to icvi@ag.ok.gov

I agree to maintain these records for five (5) years from sale date and make them available for inspection by an authorized agent of the Department.
