I understand all swine present at this event shall meet the following requirements and that these requirements must be verified before swine are allowed on the event premises:

- Verification of a federal premised identification number (PIN) or state location identifier (LID).
- Individual identification (**6 months of age or older only**)
  - Oklahoma origin swine shall be identified by both ear notch and an official electronic 840 button tag (EID/RFID).
  - Out-of-state swine shall be identified by ear notch and any form of official identification.
- Brucellosis and pseudorabies testing (Must meet one of the following options): (**6 months of age or older only**)
  - Originate from a Validated & Qualified (VQ) Herd. The VQ Herd number, most recent quarterly test date, and animal identification shall be listed on a valid Certificate of Veterinary Inspection (CVI) or other document signed by an accredited veterinarian.
  - Negative brucellosis and pseudorabies tests within 30 days prior to Special Sale. Test results, laboratory name, and animal identification shall be listed on a valid CVI or swine test chart.
- Out-of-state swine shall meet the above requirements **regardless of age** and have an ODAFF approved import permit number listed on the CVI.
  - Exception: Swine moved with an approved electronic CVI may move without an import permit once the submitting veterinarian has determined that all requirements have been met.

I understand that it is my responsibility as the Special Sale coordinator to submit the following records to ODAFF within 15 days after the event:

- Name, address, phone number, and federal PIN or state LID for all participants.
- Individual identification, age, breed, and sex of all swine.

Electronic spreadsheet is the preferred format for this record; however, other hardcopy records are acceptable. The event coordinator is not required to maintain these records once ODAFF has verified receipt.
