## WHEN TO REPORT:

All reportable diseases must be reported **immediately** to the State Veterinarian's Office upon suspicion of clinical disease. Do not wait for test results to report!

The State Veterinarian's Office can provide guidance to veterinarians on testing, appropriate biosecurity, and additional requirements, as needed.

## WHAT TO REPORT:

**Any suspected clinical case** of a reportable disease, which includes:

- If an animal dies acutely and was exhibiting clinical signs of a reportable disease, this must be reported even if no diagnostic testing was completed prior to death.
- Any highly unusual condition, unusual clinical signs of any kind, and any instance of very high morbidity and/or mortality. This includes **all foreign animal diseases\*\***, or infectious disease or parasite of livestock which was not previously known to exist in Oklahoma.
- All cases of acute equine neurologic disease must be reported immediately, unless cause is known trauma or toxicity.

Veterinary practitioners are the first line of defense in detecting Reportable and Foreign Animal Diseases. We appreciate your interest in protecting Oklahoma's livestock.

## CHARACTERISTICS OF A REPORTABLE DISEASE:

High mortality  
High morbidity (rapidly contagious)  
Vesicular Lesions  
Severe respiratory conditions  
Neurologic symptoms

Does not fit the normal clinical picture  
Severe abortion storms of unknown etiology  
Hemorrhagic septicemia  
Suspicious necropsy findings  
Poor or no response to treatment as expected
